THE PROGRAMS USE EVIDENCE-BASED STRATEGIES. OUTPATIENT DRUG AND ALCOHOL TREATMENT IS OFFERED IN COMMUNITY-BASED AND SCHOOL-SETTINGS. APPROXIMATELY 14,000 YOUTH WERE SERVED. SERVICES ARE AVAILABLE IN ENGLISH AND SPANISH.

VARIOUS HEALTH FAIRS WERE OFFERED.

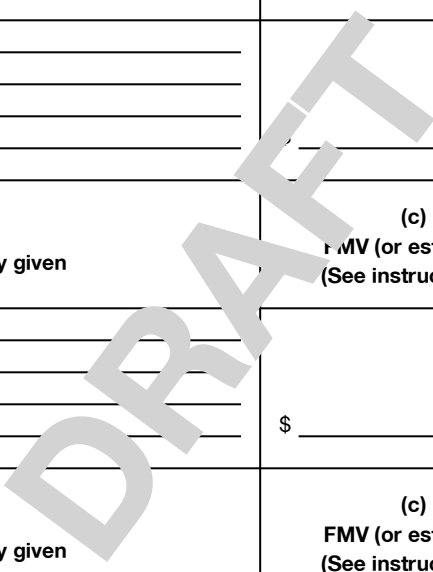

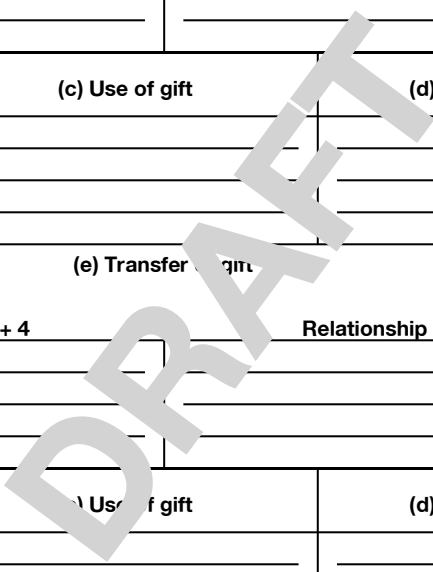

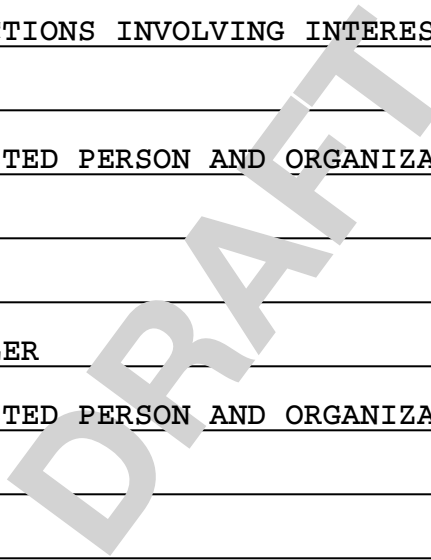
